Cook-Marks Fund

The **Cook-Marks Fund** was established by the Alan Cook Trust through California Community Foundation to support non-profit organizations doing the following:

- Mounting exhibitions of the art of puppetry
- Preservation and conservation of figures in collections
- Cataloguing puppetry collections
- Puppetry education or outreach activities designed to further skills needed for research, conservation, and exhibitions of the art of puppetry

The Fund is proud to announce a total of \$214,000 in grants to the following recipients in this cycle.

- A grant in the amount of \$5,000 to The Arroyo Arts Collective in support of restoration and cataloging of Jim Gamble Puppets.
- A grant in the amount of \$20,000 to Chinese Theatre Works (CTW) in support of their exhibit: Traditional Chinese Arts - Perpetuating Puppets and Puppetry.
- A grant in the amount of \$5,000 to Arts Mid-Hudson toward a month-lomg exhibition of puppets from the collection of Alelu Kurten, currently housed at the Ballard Institute and Museum of Puppetry, in conjunction with the 2025 Hudson Valley Puppetry Festival.
- A grant in the amount of \$5,000 to Greater Houston Puppetry Guild in support of a month-long exhibit in conjunction with the venue for the Regional Puppet Festival in Galveston, TX.
- A grant in the amount of \$25,000 to Great Arizona Puppet Theater in support of the creation of the Great Arizona Puppet Theater Gallery and Research Library.
- A grant in the amount of \$7,500 to Ebony Repertory toward the creation of a digital archive of the 50-year history of Blackstreet USA Puppet Theatre.
- A grant in the amount of \$15,000 to Bob Baker Marionettes to be used toward the cataloging, restoration and exhibition of René Zendejas' collection
- A grant in the amount of \$20,000 to Save World Art in support of the preservation, conservation and exhibition of the Portland Puppet Museum's collection.
- A grant in the amount of \$25,000 to the Center for Puppetry Arts toward the cost of documenting the museum collection through oral histories.

- A grant in the amount of \$25,000 to Carter Family Puppet Theater (dba Northwest Puppet Center) in support of the preservation, conservation and cataloging of the final two truckloads of puppets from Alan Cook's estate..
